

SAVE UP

TO KEEP MONEY FOR A SPECIFIC PURPOSE OVER TIME.

PAY OFF

TO REPAY A DEBT IN FULL.

PUT ASIDE

TO SAVE SOMETHING, USUALLY TIME OR MONEY, FOR A SPECIAL PURPOSE.

SPLASH OUT

TO SPEND A LOT OF MONEY ON SOMETHING, OFTEN LUXURIOUSLY OR UNNECESSARILY

FORK OUT

TO PAY MONEY FOR SOMETHING, USUALLY UNWILLINGLY.

CUT BACK (ON)

TO REDUCE SPENDING OR CONSUMPTION.

RIP OFF

TO CHARGE SOMEONE TOO MUCH MONEY OR TO CHEAT THEM FINANCIALLY.

GET BY

TO MANAGE TO LIVE OR SURVIVE FINANCIALLY, OFTEN WITH DIFFICULTY.

PAY BACK

TO RETURN MONEY THAT YOU BORROWED FROM SOMEBODY.

RUN OUT OF

TO FINISH ALL OF SOMETHING, SO THAT THERE IS NONE LEFT.
